➤ Status

- MOA with Insurance Management Groups (PAMI/UNITRANS) signed 15 September 2005
- **Target Date of Completion – June 2007**

➤ Total Proposed Budget - P 5 million

➤ Fund Source : PPAIP Proceeds

➤ Objectives :

- ✓ Promote continuing professional education (CPE) in terms of upgrading road safety skills, defensive driving habits and road courtesy
- ✓ Merit/Reward and Punishment/blacklisting scheme
- ✓ Operators' Responsibilities and Obligations

Preventive Maintenance Plan/Schedule for PUVs



- Initial Coordination with Truck Manufacturer' Association of the Philippines to prepare comprehensive Preventive Maintenance Schedule/Plan for PUBs
- Comprehensive Maintenance Plan for Taxis, AUVs and Vans in coordination with AAP and SOPI is being explored

Land International Security and Commuters Advocacy Protocol (LAND IS CAP)



- **Status: Project Proposal for APEC-funding amounting to \$ 100,000.00**

(Target Date of Implementation November 2006- June 2007)

- **Components:**

Codified Compendium of Public Land Transport Security and Counter-Terrorism “Best Practices” similar to IMO/ISPS and ICAO

Commuters’ Advocacy Campaign on Core Elements of Counter-Terrorism/Safety for Public Land Transport

Passenger Rights and Accident Response Action Plan



- **Implementation of PPAIP-CTPL with Additional Benefits (i.e. All Risk-No Fault, Automatic Hospitalization and Payment within 5-days, etc.)**
- **PUV compliance for emergency equipment and paraphernalia (i.e. fire extinguishers, two-way radio, stretchers, neck/spine braces and other medical equipment)**
- **Training for Transport workers relative to on-board fire-fighting, first aid and other emergency interventions.**
